

# Owego Apalachin Central School District

## SMART Schools Investment Plan Summary

The SMART Schools Bond Act was passed in the State 2014-15 Enacted Budget and approved by voters in a statewide referendum held during the 2014 general election. The SMART Schools Bond Act (SSBA) authorized the issuance of \$2 billion of general obligation bonds to finance improved educational technology and infrastructure needs for school districts in New York State. The SSBA requires that a state sponsored committee review and approve all district SMART School project proposals.

The Owego Apalachin Central School District qualified for \$1,753,478 from the SMART Schools Bond Act. This funding can be used for any of the following categories:

1. Install high-speed broadband or wireless internet connectivity for schools and communities;
2. Acquire learning technology equipment or facilities, including but not limited to interactive whiteboards, computer servers, and desktop, laptop, and tablet computers;
3. Construct, enhance, and modernize educational facilities to accommodate prekindergarten programs and to provide instructional space to replace classroom trailers; and/or
4. Install high-tech security features in school buildings and on school campuses, including but not limited to video surveillance, emergency notification systems, and physical access controls.

All districts are required to submit a SMART Schools Investment Plan to demonstrate how SMART Schools Bond Act funds will be used to benefit students.

All projects associated with SMART Schools Bond Act funds must be approved by the New York State Education Department. The process to receive funds for SMART Schools projects requires each district to expend district funds upfront, submit final cost reports to the State Education Department, and then receive full reimbursement.

In addition, as part of the overall approval process, the school district held a SMART Schools Committee meeting on July 29<sup>th</sup> to finalize recommendations from district stakeholders committed to our SMART Schools project.

Below is a project summary outlining the district's intentions for utilizing the SMART Schools funds. This summary and scope will be available on our district website beginning July 29<sup>th</sup> through August 29<sup>th</sup>. A public hearing regarding this project will take place on August 29<sup>th</sup> at 9:30 am before the regularly scheduled Board of Education meeting. The final plan will be recommended for approval by the Board of Education on September 9<sup>th</sup>.

## Project Summary

### *High Tech Security Features*

- **Notification System** – provide an advanced notification system in all areas in all buildings. The system will be used to notify all occupants of any emergency through digital display and strobe lights. This system will also incorporate our clocks and public-address system as well.
  - Project Cost: **\$571,411**
- **Access Controls System** – provide advanced door hardware for automatic lockdown procedures. All doors in all buildings will be able to lockdown in the event of an emergency.
  - Project Cost: **\$1,088,170**
- **Contingency and Incidentals**
  - Project Cost: **\$93,897**
